

The highest total for a first half year in Aberdeenshire occurred in 2007 when a total of 2,255 were formed.

new companies by half year




Quarterly Data (Q2 Apr-Jun 2012)



dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2012)



net growth by half year















director age by half year






director age by quarter
