


The second half of 2011 saw a new record in company registrations in Abingdon when compared to any previous second half year.

new companies by half year




Q4 2011 saw a new record in company registrations in Abingdon when compared to any previous Q4.





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




Q4 2011 saw a new record in company closures in Abingdon when compared to any previous Q4.




A total of 94 companies were added to the company register for Abingdon in 2011. This number represents growth of 35.9% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)





Monthly Data (Oct, Nov & Dec 2011)






company share by year







director age by year





director age by quarter





director gender by year




Half Year Data (Jul-Dec 2011)
