




# Quarterly Data (Q2 Apr-Jun 2012)



#### dissolved companies by half year




# Quarterly Data (Q2 Apr-Jun 2012)










company share by half year





## director age by half year



The percentage of directors under the age of 25 was 2.7% compared to the UK figure of 5.2%.


The percentage of directors over the age of 65 was 0.9% compared to the UK figure of 3.3%.
