

#### new companies by year




## Half Year Data (Jul-Dec 2011)


#### new companies by half year



dissolved companies by year




## Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 71 companies were dissolved in Accrington. This figure is 33.6% lower than last year, which compares well to the UK wide change of -7.5%.

#### dissolved companies by half year




A total of 41 companies were dissolved in Accrington during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 96 companies were added to the company register for Accrington in 2011. This number represents growth of 49.2% which compares favourably to the UK figure of 34.6%.

#### net growth by year




## Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Accrington during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 11 companies.

#### net growth by quarter






company share by year







#### director age by year




#### director age by half year


#### director age by quarter

#### director gender by year




## Half Year Data (Jul-Dec 2011)
