




Half Year Data (Jul-Dec 2011)


Q4 2011 saw a new record in company registrations in Addlestone when compared to any previous Q4.






A total of 22 companies were dissolved in Addlestone during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 40 companies were added to the company register for Addlestone in 2011. This number represents growth of 27.0% which compares unfavourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)






company share by year







director age by year





director age by half year



26.5% of all director appointments in Addlestone in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


