




Half Year Data (Jul-Dec 2011)



dissolved companies by year




Half Year Data (Jul-Dec 2011)


dissolved companies by half year


A total of 53 companies were added to the company register for Alfreton in 2011. This number represents growth of 41.4% which compares favourably to the UK figure of 34.6%.

net growth by year










company share by year



company share by half year





director age by year




director age by half year
