
The first half of 2012 was a record first half year for company registrations in Andover when compared to any half year in history.

In the first half of 2012 a total of 172 companies were formed in Andover. This figure is 43.3% higher than last year, which compares well to the UK wide figure of 10.7%.

#### new companies by half year




#### Quarterly Data (Q2 Apr-Jun 2012)





#### dissolved companies by half year





A total of 45 companies were dissolved in Andover during the second quarter of 2012 (Apr 2012 - Jun 2012).





#### net growth by half year













#### director age by half year





The percentage of directors over the age of 65 was 4.1% compared to the UK figure of 3.3%.


#### director age by quarter
