

Q2 2011 saw a new record in company registrations in Ascot when compared to any previous Q2.


Q2 2011 was a record quarter for company registrations in Ascot when compared to any quarter in history.

dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2011)







net growth by quarter



net growth by month






company share by half year





director age by half year





The percentage of directors over the age of 65 was 1.2% compared to the UK figure of 4.3%.






The record first half year for female directors in Ascot was 1857 when 40.0% of all directors were female.

26.4% of all director appointments in Ascot in the first half of 2011 were female. This compares to a UK average of 25.7% for the same period.


director gender by half year
