• October 2011 saw a new record in net growth in Banbury when compared to any previous October.



A total of 427 companies were formed in Banbury in 2011. This total is 4.9% higher than in 2010 and compares favourably to the UK figure of a 13.1% growth compared to 400,358 the previous year.

#### new companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 218 companies were formed in Banbury. This figure is 19.8% higher than last year, which compares well to the UK wide figure of 14.0%.

The highest total for a second half year in Banbury occurred in 2003 when a total of 230 were formed.

#### new companies by half year




A total of 106 companies were registered in Banbury during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





#### dissolved companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 139 companies were dissolved in Banbury. This figure is 2.2% higher than last year, which compares badly to the UK wide change of -7.5%.

The highest total for a second half year in Banbury occurred in 2009 when a total of 190 were closed.

## dissolved companies by half year




A total of 63 companies were dissolved in Banbury during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 157 companies were added to the company register for Banbury in 2011. This number represents growth of 38.6% which compares favourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Banbury during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 43 companies.


#### net growth by quarter






#### company share by half year





#### director age by year





#### director age by half year




The average age of a director in the fourth quarter of 2011 was 45.2.

#### director gender by year




## Half Year Data (Jul-Dec 2011)
