

new companies by half year





A total of 109 companies were registered in Banbury during the second quarter of 2012 (Apr 2012 - Jun 2012).





dissolved companies by half year





A total of 65 companies were dissolved in Banbury during the second quarter of 2012 (Apr 2012 - Jun 2012).





net growth by half year













director age by half year






director age by quarter
