

new companies by year




Half Year Data (Jul-Dec 2011)


Q4 2011 saw a new record in company registrations in Banstead when compared to any previous Q4.





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 22 companies were dissolved in Banstead during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 27 companies were added to the company register for Banstead in 2011. This number represents growth of 25.2% which compares unfavourably to the UK figure of 34.6%.

net growth by year



net growth by half year




Net company growth for Banstead during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 9 companies.








company share by half year





director age by year





director age by half year




director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)
