The first half of 2011 saw a new record in company registrations in Barnet when compared to any previous first half year.


The first half of 2011 was a record first half year for company registrations in Barnet when compared to any half year in history.

In the first half of 2011 a total of 567 companies were formed in Barnet. This figure is 6.6% higher than last year, which compares badly to the UK wide figure of 12.3%.

The highest total for a first half year in Barnet occurred in 2011 when a total of 567 were formed.


Q2 2011 saw a new record in company registrations in Barnet when compared to any previous Q2.

A total of 280 companies were registered in Barnet during the second quarter of 2011 (Apr 2011 - Jun 2011).

This figure is an increase of 2.6% versus the same period last year (Q2 2010). This figure compares badly to the UK as a whole, which saw an increase of 13.9% against the same period last year.





#### dissolved companies by half year




## Quarterly Data (Q2 Apr-Jun 2011)





#### net growth by half year













#### director age by half year




## Quarterly Data (Q2 Apr-Jun 2011)

The percentage of directors over the age of 65 was 4.8% compared to the UK figure of 4.3%.


#### director age by quarter
