


A total of 232 companies were registered in Barnet during the third quarter of 2011 (Jul 2011 - Sep 2011).


new companies by quarter














Quarterly Data (Q3 Jul-Sep 2011)

The percentage of directors over the age of 65 was 4.7% compared to the UK figure of 4.1%.


director age by quarter
