In the first half of 2011 a total of 379 companies were formed in Barnsley. This figure is 18.4% higher than last year, which compares well to the UK wide figure of 12.3%.

The highest total for a first half year in Barnsley occurred in 2011 when a total of 379 were formed.


Q2 2011 saw a new record in company registrations in Barnsley when compared to any previous Q2.





dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2011)



net growth by half year









company share by half year







director age by half year





director gender by half year


