

#### new companies by year




## Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 123 companies were formed in Barrow-In-Furness. This figure is 16.0% higher than last year, which compares well to the UK wide figure of 14.0%.

The highest total for a second half year in Barrow-In-Furness occurred in 2003 when a total of 141 were formed.




A total of 48 companies were registered in Barrow-In-Furness during the fourth quarter of 2011 (Oct 2011 - Dec 2011).






## Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 92 companies were dissolved in Barrow-In-Furness. This figure is 2.2% higher than last year, which compares badly to the UK wide change of -7.5%.

The highest total for a second half year in Barrow-In-Furness occurred in 2009 when a total of 127 were closed.

## dissolved companies by half year




A total of 49 companies were dissolved in Barrow-In-Furness during the fourth quarter of 2011 (Oct 2011 - Dec 2011).








## Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Barrow-In-Furness during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was -1 companies.

This represents a decrease of 114.3% on the same period last year.











#### director age by year




## Half Year Data (Jul-Dec 2011)

#### director age by half year




The average age of a director in the fourth quarter of 2011 was 39.7.

The percentage of directors over the age of 65 was 3.0% compared to the UK figure of 4.1%.


## director age by quarter

#### director gender by year




## Half Year Data (Jul-Dec 2011)

## director gender by half year


