


The second half of 2011 saw a new record in company registrations in Basingstoke when compared to any previous second half year.

new companies by half year




Q4 2011 saw a new record in company registrations in Basingstoke when compared to any previous Q4.


new companies by quarter



dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




Q4 2011 saw a new record in company closures in Basingstoke when compared to any previous Q4.


dissolved companies by quarter


A total of 216 companies were added to the company register for Basingstoke in 2011. This number represents growth of 28.2% which compares unfavourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Basingstoke during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 45 companies.








company share by half year





director age by year





director age by half year




director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)
