




Quarterly Data (Q2 Apr-Jun 2012)



dissolved companies by half year





A total of 33 companies were dissolved in Beaconsfield during the second quarter of 2012 (Apr 2012 - Jun 2012).







net growth by quarter






company share by half year





director age by half year






director age by quarter

director gender by half year


