

A total of 464 companies were formed in Beckenham in 2011. This total is 2.2% higher than in 2010 and compares favourably to the UK figure of a 13.1% growth compared to 400,358 the previous year.

### Half Year Data (Jul-Dec 2011)


The second half of 2011 saw a new record in company registrations in Beckenham when compared to any previous second half year.

#### new companies by half year




Q4 2011 saw a new record in company registrations in Beckenham when compared to any previous Q4.



In the second half of 2011 a total of 182 companies were dissolved in Beckenham. This figure is 5.2% lower than last year, which compares badly to the UK wide change of -7.5%.

#### dissolved companies by half year




Q4 2011 saw a new record in company closures in Beckenham when compared to any previous Q4.




A total of 135 companies were added to the company register for Beckenham in 2011. This number represents growth of 29.7% which compares unfavourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)

#### net growth by half year








company share by year





#### director age by year








#### director age by quarter
