The first half of 2011 saw a new record in company registrations in Bedford when compared to any previous first half year.


The first half of 2011 was a record first half year for company registrations in Bedford when compared to any half year in history.

In the first half of 2011 a total of 675 companies were formed in Bedford. This figure is 8.3% higher than last year, which compares badly to the UK wide figure of 12.3%.


Q2 2011 saw a new record in company registrations in Bedford when compared to any previous Q2.





dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2011)





net growth by half year






net growth by quarter



company share by half year







director age by half year






director age by quarter
