The first half of 2011 saw a new record in company registrations in Belfast when compared to any previous first half year.


The first half of 2011 was a record first half year for company registrations in Belfast when compared to any half year in history.

In the first half of 2011 a total of 756 companies were formed in Belfast. This figure is 24.1% higher than last year, which compares well to the UK wide figure of 12.3%.

The highest total for a first half year in Belfast occurred in 2011 when a total of 756 were formed.

#### new companies by half year




#### Quarterly Data (Q2 Apr-Jun 2011)

A total of 380 companies were registered in Belfast during the second quarter of 2011 (Apr 2011 - Jun 2011).




The first half of 2011 saw a new record in company closures in Belfast when compared to any previous first half year.

In the first half of 2011 a total of 531 companies were dissolved in Belfast. This figure is 12.5% higher than last year, which compares badly to the UK wide change of -8.6%.

The highest total for a first half year in Belfast occurred in 2011 when a total of 531 were closed.

#### dissolved companies by half year




#### Quarterly Data (Q2 Apr-Jun 2011)

This figure is a decrease of 21.7% versus the same period last year (Q2 2010). This figure compares poorly to the UK as a whole, which saw a decrease of 24.9% against the same period last year.



#### dissolved companies by month



#### net growth by half year





This represents an increase of 162.6% on the same period last year.











#### director age by half year





The percentage of directors over the age of 65 was 6.3% compared to the UK figure of 4.3%.


#### director age by quarter
