

2011 was a record year for company registrations in Belfast when compared to any year in history.

A total of 1,509 companies were formed in Belfast in 2011. This total is 16.3% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.


The second half of 2011 saw a new record in company registrations in Belfast when compared to any previous second half year.

In the second half of 2011 a total of 753 companies were formed in Belfast. This figure is 9.3% higher than last year, which compares badly to the UK wide figure of 14.0%.

The highest total for a second half year in Belfast occurred in 2011 when a total of 753 were formed.

#### new companies by half year




Q4 2011 saw a new record in company registrations in Belfast when compared to any previous Q4.

A total of 383 companies were registered in Belfast during the fourth quarter of 2011 (Oct 2011 - Dec 2011).

This figure is an increase of 3.8% versus the same period last year (Q4 2010). This figure compares badly to the UK as a whole, which saw an increase of 15.3% against the same period last year.





#### dissolved companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 497 companies were dissolved in Belfast. This figure is 55.7% lower than last year, which compares well to the UK wide change of -7.5%.

The highest total for a second half year in Belfast occurred in 2010 when a total of 1,123 were closed.

#### dissolved companies by half year




A total of 256 companies were dissolved in Belfast during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 481 companies were added to the company register for Belfast in 2011. This number represents growth of 37.1% which compares favourably to the UK figure of 34.6%.

The highest net company growth figure ever seen in one year came in 2007 when the Belfast company register grew by 1,275 companies.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Belfast during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 127 companies.

This represents an increase of 169.0% on the same period last year.





#### company share by year




#### company share by half year





#### director age by year





#### director age by half year




The average age of a director in the fourth quarter of 2011 was 43.8.

The percentage of directors over the age of 65 was 4.2% compared to the UK figure of 4.1%.


#### director age by quarter

#### director gender by year




## Half Year Data (Jul-Dec 2011)

#### director gender by half year


