The first half of 2012 saw a new record in company registrations in Belfast when compared to any previous first half year.


The first half of 2012 was a record first half year for company registrations in Belfast when compared to any half year in history.

In the first half of 2012 a total of 888 companies were formed in Belfast. This figure is 17.5% higher than last year, which compares well to the UK wide figure of 10.7%.

The highest total for a first half year in Belfast occurred in 2012 when a total of 888 were formed.


Q2 2012 saw a new record in company registrations in Belfast when compared to any previous Q2.

A total of 423 companies were registered in Belfast during the second quarter of 2012 (Apr 2012 - Jun 2012).

This figure is an increase of 11.3% versus the same period last year (Q2 2011). This figure compares equally to the UK as a whole, which saw an increase of 8.3% against the same period last year.



#### new companies by month





#### dissolved companies by half year




#### Quarterly Data (Q2 Apr-Jun 2012)





#### net growth by half year





This represents an increase of 166.1% on the same period last year.





#### company share by half year







#### director age by half year





The percentage of directors over the age of 65 was 5.6% compared to the UK figure of 3.3%.


#### director age by quarter
