

new companies by half year




Quarterly Data (Q2 Apr-Jun 2011)



dissolved companies by half year





A total of 33 companies were dissolved in Beverley during the second quarter of 2011 (Apr 2011 - Jun 2011).





net growth by half year







net growth by month





company share by half year







director age by half year






director age by quarter

director gender by half year


