



new companies by half year




Quarterly Data (Q2 Apr-Jun 2012)





dissolved companies by half year









net growth by half year





This represents a decrease of 18.4% on the same period last year.



net growth by month





company share by half year







director age by half year






director age by quarter

director gender by half year


