

#### new companies by year




## Half Year Data (Jul-Dec 2011)

The second half of 2011 saw a new record in company registrations in Bicester when compared to any previous second half year.

In the second half of 2011 a total of 187 companies were formed in Bicester. This figure is 45.0% higher than last year, which compares well to the UK wide figure of 14.0%.


Q4 2011 saw a new record in company registrations in Bicester when compared to any previous Q4.


#### new companies by quarter

October 2011 saw a new record in company registrations in Bicester when compared to any previous October.





dissolved companies by year




# Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 97 companies were dissolved in Bicester. This figure is 32.6% lower than last year, which compares well to the UK wide change of -7.5%.

## dissolved companies by half year




A total of 48 companies were dissolved in Bicester during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 130 companies were added to the company register for Bicester in 2011. This number represents growth of 48.3% which compares favourably to the UK figure of 34.6%.

#### net growth by year




## Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Bicester during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 45 companies.




company share by year







#### director age by year




## Half Year Data (Jul-Dec 2011)

The percentage of directors over the age of 65 was 4.2% compared to the UK figure of 4.1%.






The average age of a director in the fourth quarter of 2011 was 46.0.

The record second half year for female directors in Bicester was 1860 when 42.9% of all directors were female.

28.5% of all director appointments in Bicester in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.
