The highest total for a first half year in Bicester occurred in 2007 when a total of 311 were formed.


Q2 2012 saw a new record in company registrations in Bicester when compared to any previous Q2.





dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2012)



net growth by half year









company share by half year







director age by half year






director age by quarter
