


Half Year Data (Jul-Dec 2011)

new companies by half year




A total of 27 companies were registered in Bideford during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 10 companies were dissolved in Bideford during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 48 companies were added to the company register for Bideford in 2011. This number represents growth of 49.5% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Bideford during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 17 companies.








company share by half year





director age by year





director age by half year




director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)
