

2011 was a record year for company registrations in Biggleswade when compared to any year in history.

A total of 109 companies were formed in Biggleswade in 2011. This total is 45.3% higher than in 2010 and compares poorly to the UK figure of a 13.1% growth compared to 400,358 the previous year.

Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 50 companies were formed in Biggleswade. This figure is 19.0% higher than last year, which compares well to the UK wide figure of 14.0%.




A total of 24 companies were registered in Biggleswade during the fourth quarter of 2011 (Oct 2011 - Dec 2011).






A total of 13 companies were dissolved in Biggleswade during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 52 companies were added to the company register for Biggleswade in 2011. This number represents growth of 69.3% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Biggleswade during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 11 companies.




company share by year




company share by half year





director age by year





director gender by year




Half Year Data (Jul-Dec 2011)
