

## Half Year Data (Jul-Dec 2011)


The second half of 2011 saw a new record in company registrations in Billericay when compared to any previous second half year.

#### new companies by half year




A total of 94 companies were registered in Billericay during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


#### new companies by quarter



#### dissolved companies by year




## Half Year Data (Jul-Dec 2011)

#### dissolved companies by half year




A total of 58 companies were dissolved in Billericay during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 175 companies were added to the company register for Billericay in 2011. This number represents growth of 44.4% which compares favourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Billericay during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 36 companies.

This represents a decrease of 7.7% on the same period last year.








## company share by half year





#### director age by year





#### director age by half year




## director age by quarter

#### director gender by year




# Half Year Data (Jul-Dec 2011)
