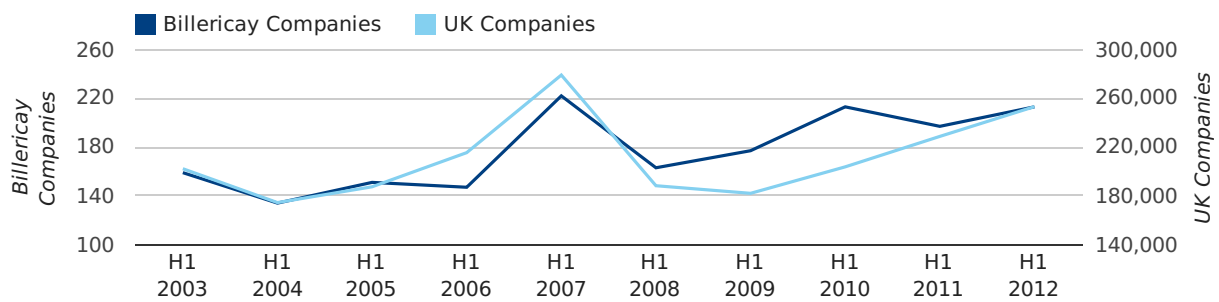
### Half Year Data (Jan-Jun 2012)

In the first half of 2012 a total of 213 companies were formed in Billericay. This figure is 8.1% higher than last year, which compares badly to the UK wide figure of 10.7%.

The highest total for a first half year in Billericay occurred in 2007 when a total of 222 were formed.

### new companies by half year



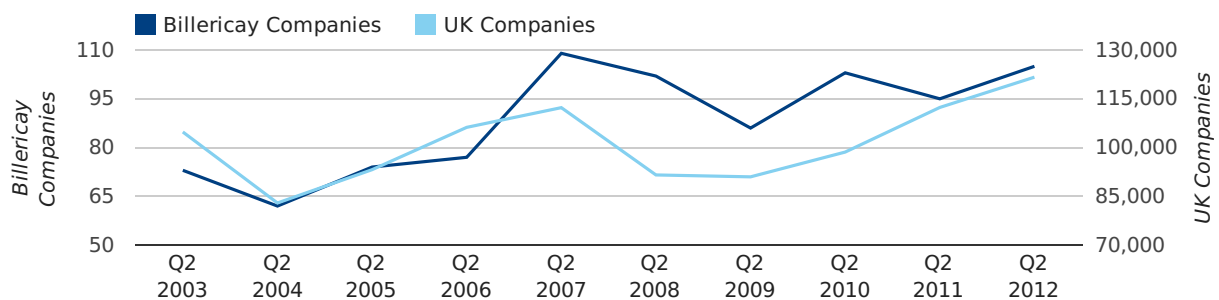
### Quarterly Data (Q2 Apr-Jun 2012)

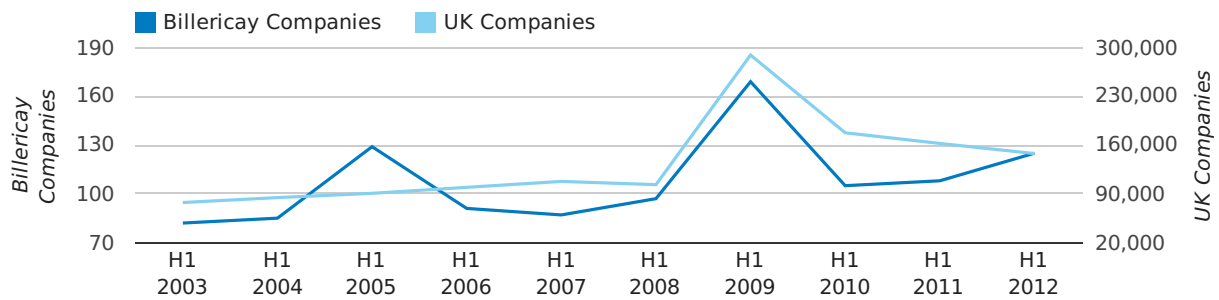
### Half Year Data (Jan-Jun 2012)

In the first half of 2012 a total of 125 companies were dissolved in Billericay. This figure is 15.7% higher than last year, which compares badly to the UK wide change of -8.9%.

The highest total for a first half year in Billericay occurred in 2009 when a total of 169 were closed.

### dissolved companies by half year



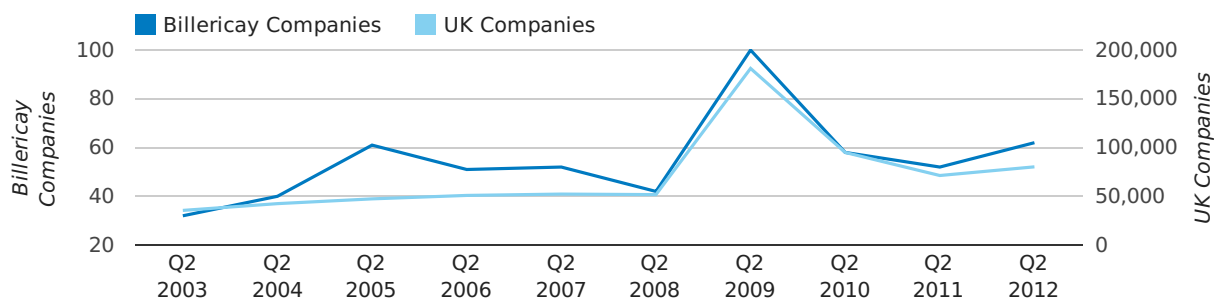
### Quarterly Data (Q2 Apr-Jun 2012)

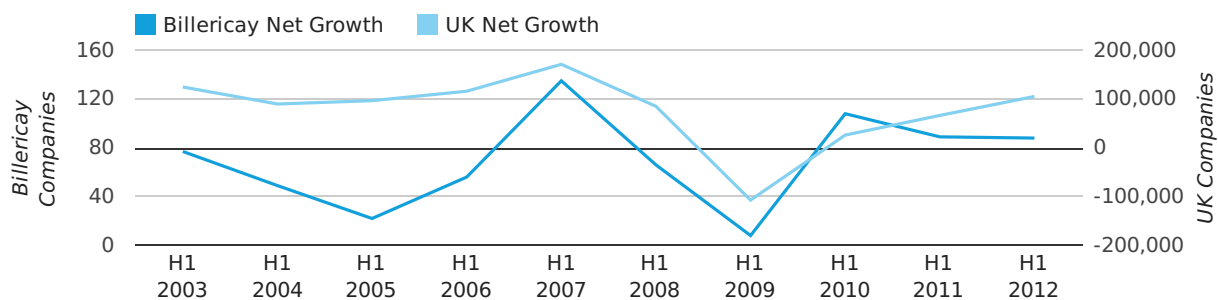

### net growth by half year



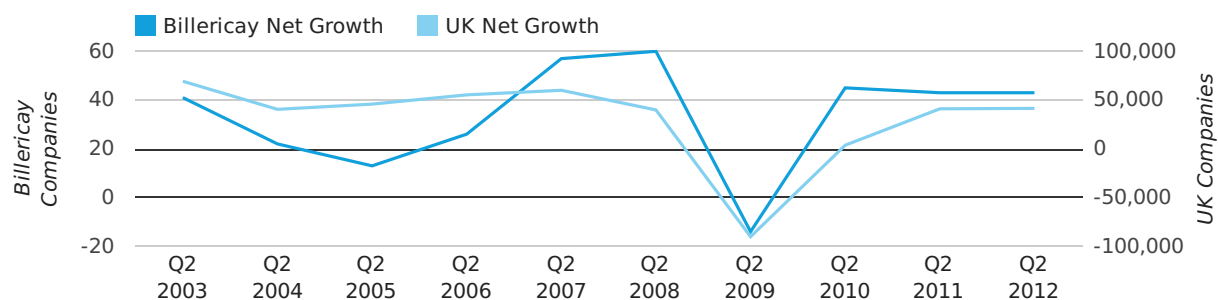

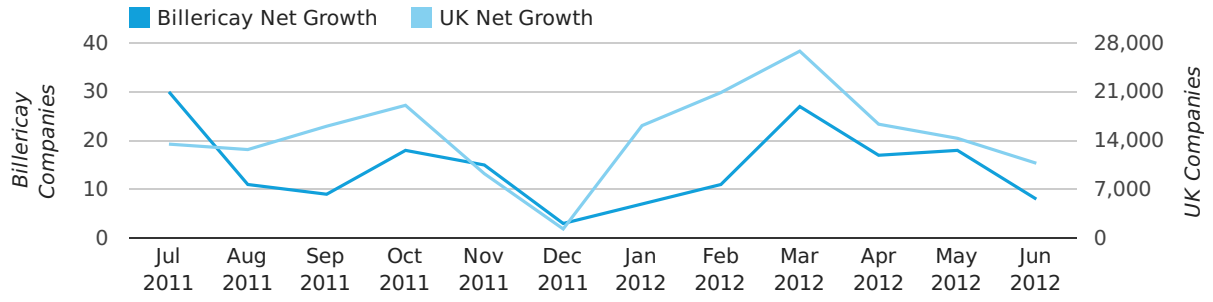

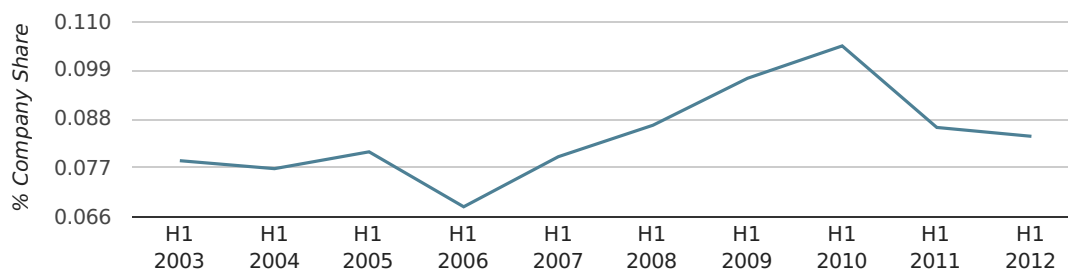

### company share by half year

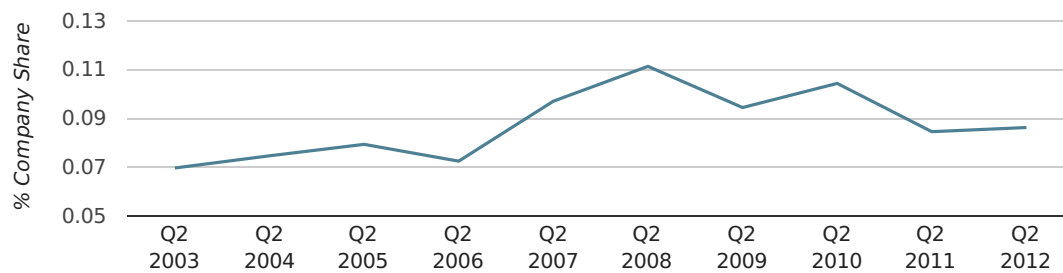

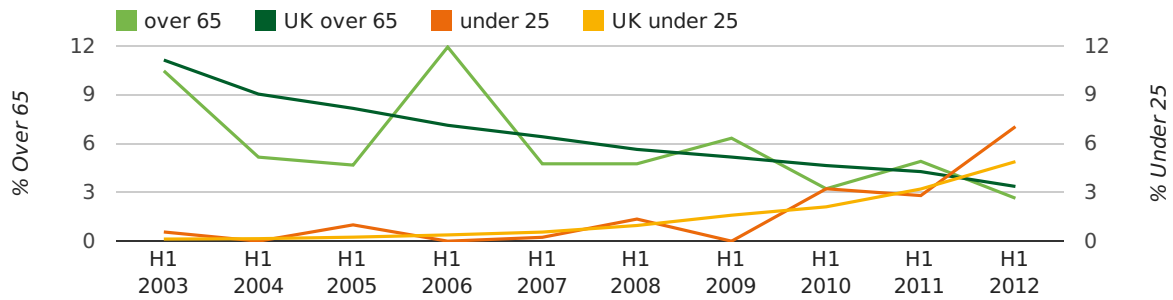
### Half Year Data (Jan-Jun 2012)

#### director age by half year



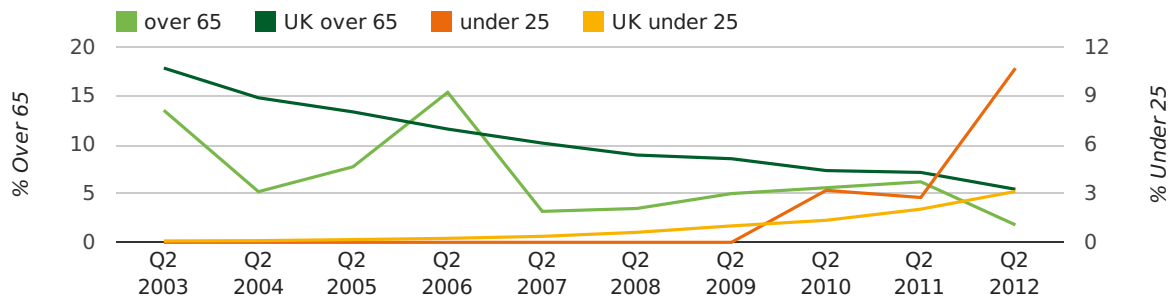
### Quarterly Data (Q2 Apr-Jun 2012)

#### director age by quarter

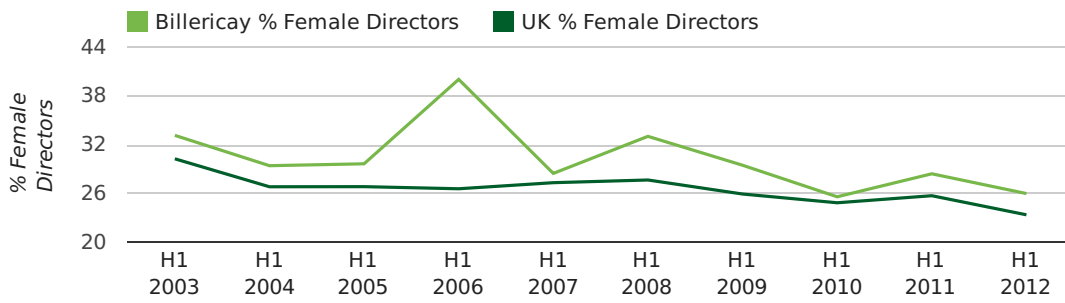


### Half Year Data (Jan-Jun 2012)

The record first half year for female directors in Billericay was 1861 when 40.0% of all directors were female.

26.0% of all director appointments in Billericay in the first half of 2012 were female. This compares to a UK average of 23.4% for the same period.

#### director gender by half year

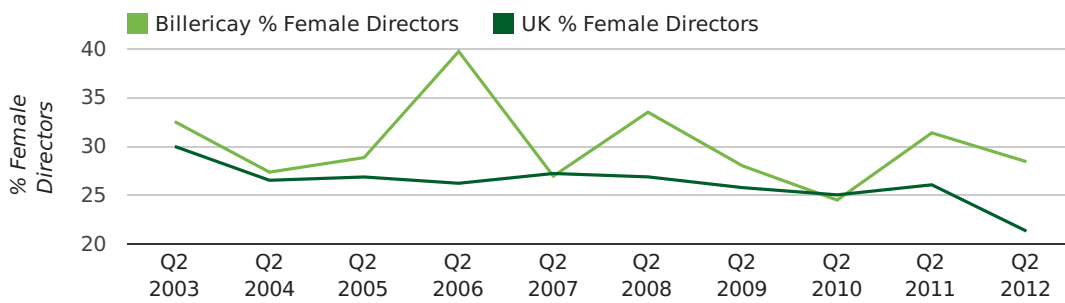


### Quarterly Data (Q2 Apr-Jun 2012)

The record second quarter for female directors in Billericay was in 1866 when 66.7% of all directors were female.

28.5% of all director appointments in Billericay in the second quarter of 2012 were female. This compares to a UK average of 21.3% for the same period.
