

A total of 158 companies were formed in Bingley in 2011. This total is 12.1% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.

#### new companies by year




## Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 63 companies were formed in Bingley. This figure is 1.6% higher than last year, which compares badly to the UK wide figure of 14.0%.

The highest total for a second half year in Bingley occurred in 2009 when a total of 64 were formed.

#### new companies by half year




A total of 27 companies were registered in Bingley during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


#### new companies by quarter



## dissolved companies by year




# Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 42 companies were dissolved in Bingley. This figure is 16.7% higher than last year, which compares badly to the UK wide change of -7.5%.

The highest total for a second half year in Bingley occurred in 2006 when a total of 55 were closed.

# dissolved companies by half year




A total of 21 companies were dissolved in Bingley during the fourth quarter of 2011 (Oct 2011 - Dec 2011).



2011 was a record year for net growth in Bingley when compared to any year in history.


A total of 70 companies were added to the company register for Bingley in 2011. This number represents growth of 49.6% which compares favourably to the UK figure of 34.6%.

#### net growth by year




# Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Bingley during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 6 companies.

This represents a decrease of 68.4% on the same period last year.











#### director age by year




# Half Year Data (Jul-Dec 2011)

#### director age by half year




The average age of a director in the fourth quarter of 2011 was 50.3.

The percentage of directors over the age of 65 was 9.3% compared to the UK figure of 4.1%.


# director age by quarter

#### director gender by year




# Half Year Data (Jul-Dec 2011)

## director gender by half year


