




#### new companies by half year





The second half of 2011 saw a new record in company closures in Blandford Forum when compared to any previous second half year.

In the second half of 2011 a total of 59 companies were dissolved in Blandford Forum. This figure is 63.9% higher than last year, which compares badly to the UK wide change of -7.5%.

The highest total for a second half year in Blandford Forum occurred in 2011 when a total of 59 were closed.

#### dissolved companies by half year




Q4 2011 saw a new record in company closures in Blandford Forum when compared to any previous Q4.

A total of 30 companies were dissolved in Blandford Forum during the fourth quarter of 2011 (Oct 2011 - Dec 2011).

This figure is an increase of 87.5% versus the same period last year (Q4 2010). This figure compares poorly to the UK as a whole, which saw an increase of 4.0% against the same period last year.





#### net growth by year




#### Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Blandford Forum during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was -1 companies.

This represents a decrease of 106.3% on the same period last year.






#### company share by year







#### director age by year



The percentage of directors over the age of 65 was 4.7% compared to the UK figure of 4.1%.



#### director age by quarter





#### director gender by year




## Half Year Data (Jul-Dec 2011)

29.8% of all director appointments in Blandford Forum in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


#### director gender by half year
