

The second half of 2011 saw a new record in company registrations in Bodmin when compared to any previous second half year.


The second half of 2011 was a record second half year for company registrations in Bodmin when compared to any half year in history.

Q4 2011 saw a new record in company registrations in Bodmin when compared to any previous Q4.


Q4 2011 was a record quarter for company registrations in Bodmin when compared to any quarter in history.

new companies by quarter







dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 14 companies were dissolved in Bodmin during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


dissolved companies by quarter

2011 was a record year for net growth in Bodmin when compared to any year in history.


A total of 74 companies were added to the company register for Bodmin in 2011. This number represents growth of 77.1% which compares favourably to the UK figure of 34.6%.






net growth by quarter

net growth by month






company share by half year





director age by year





director age by half year




director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)
