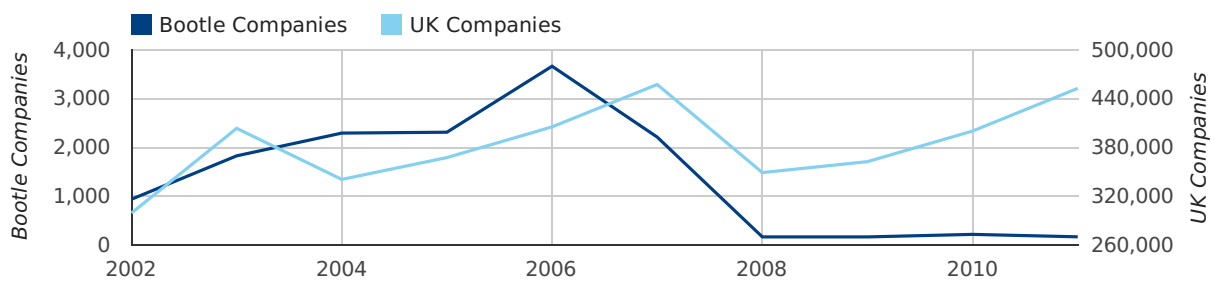

Annual Data (2011)

A total of 169 companies were formed in Bootle in 2011. This total is 22.8% lower than in 2010 and compares favourably to the UK figure of a 13.1% growth compared to 400,358 the previous year.

new companies by year



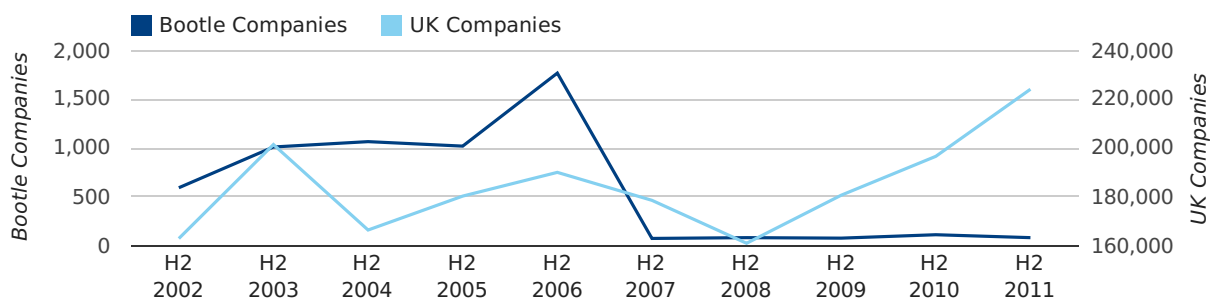
Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 81 companies were formed in Bootle. This figure is 27.0% lower than last year, which compares badly to the UK wide figure of 14.0%.

The highest total for a second half year in Bootle occurred in 2006 when a total of 1,769 were formed.

new companies by half year



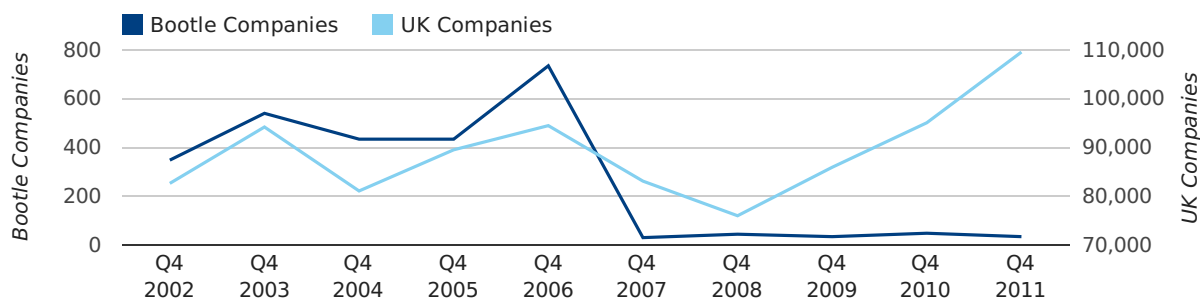
Quarterly Data (Q4 Oct-Dec 2011)

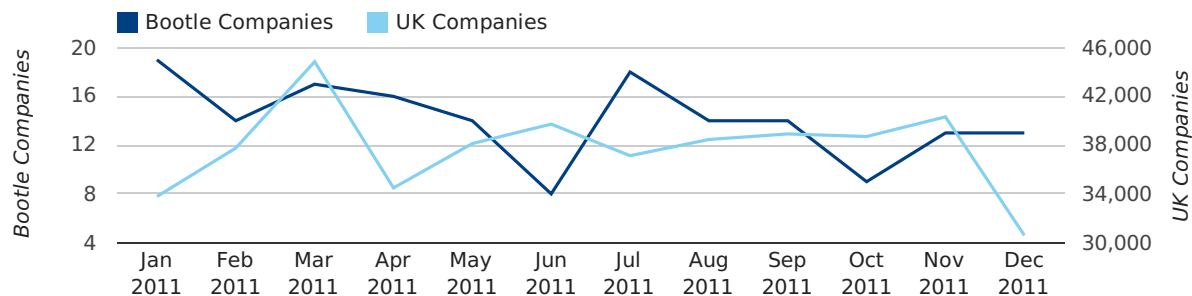

A total of 130 companies were dissolved in Bootle in 2011. This total is 37.2% lower than in 2010 and compares unfavourably to the UK figure of 8.1% decrease compared to the previous year.

dissolved companies by year



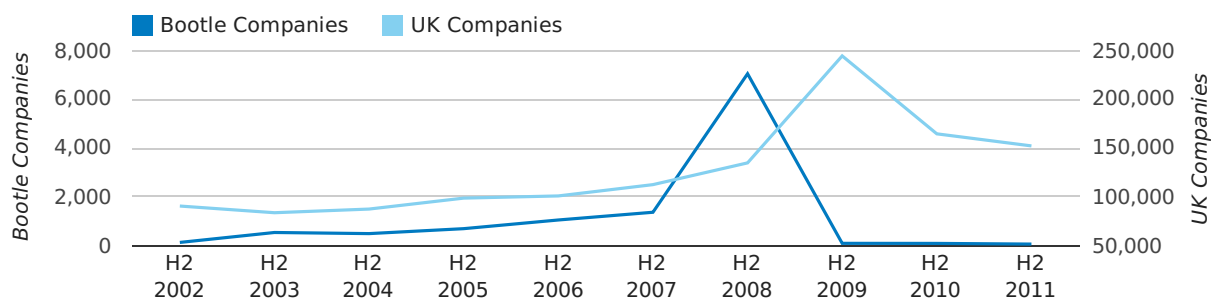
Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 60 companies were dissolved in Bootle. This figure is 31.8% lower than last year, which compares well to the UK wide change of -7.5%.

The highest total for a second half year in Bootle occurred in 2008 when a total of 7,049 were closed.

dissolved companies by half year



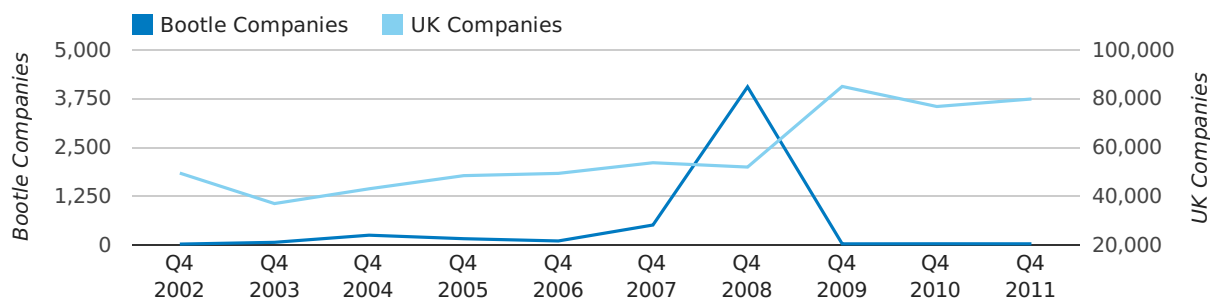

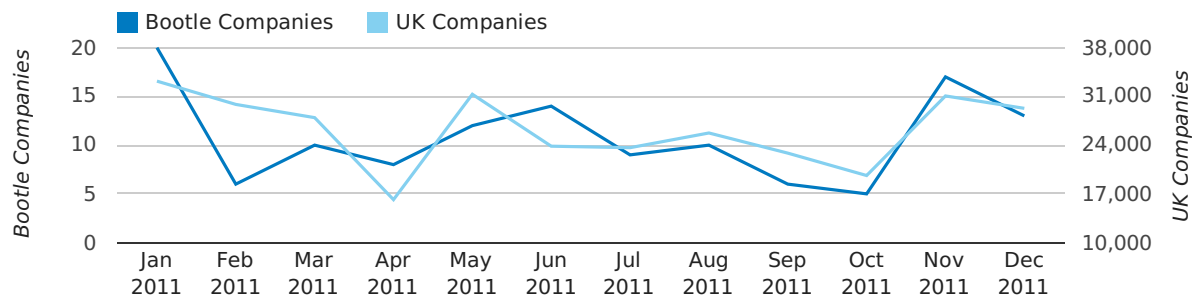

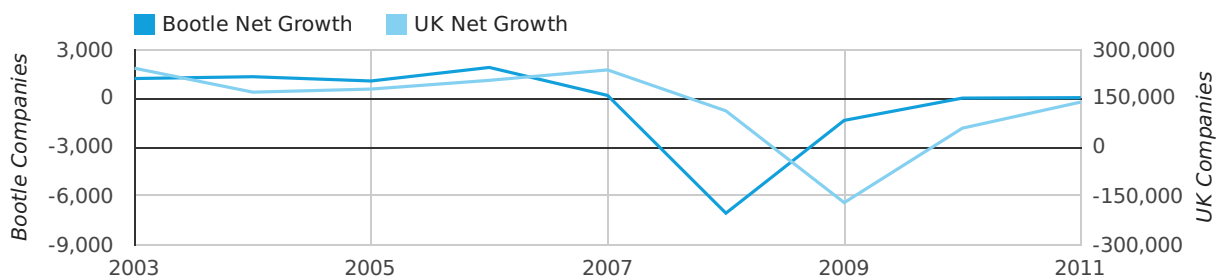
A total of 39 companies were added to the company register for Bootle in 2011. This number represents growth of 17.8% which compares unfavourably to the UK figure of 34.6%.

net growth by year

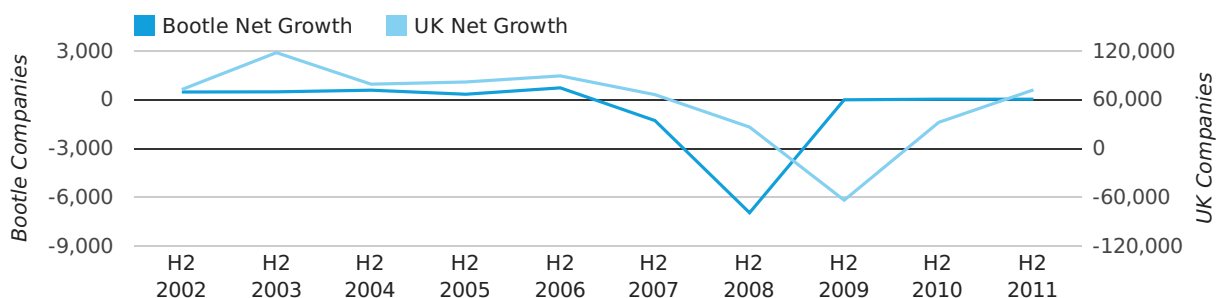


Half Year Data (Jul-Dec 2011)

net growth by half year



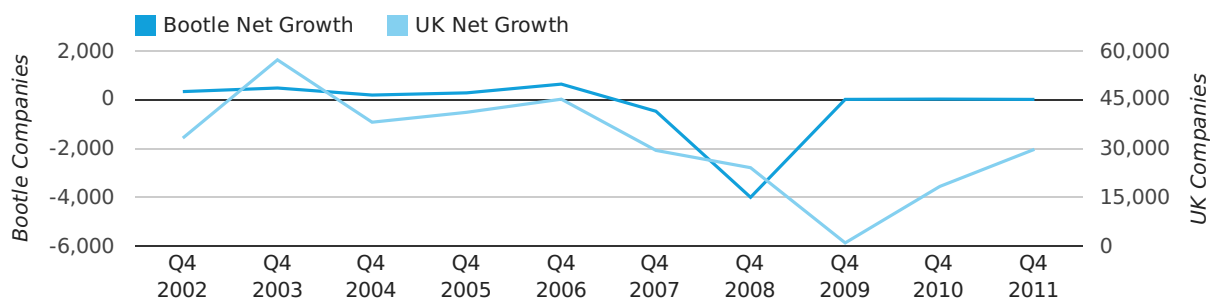

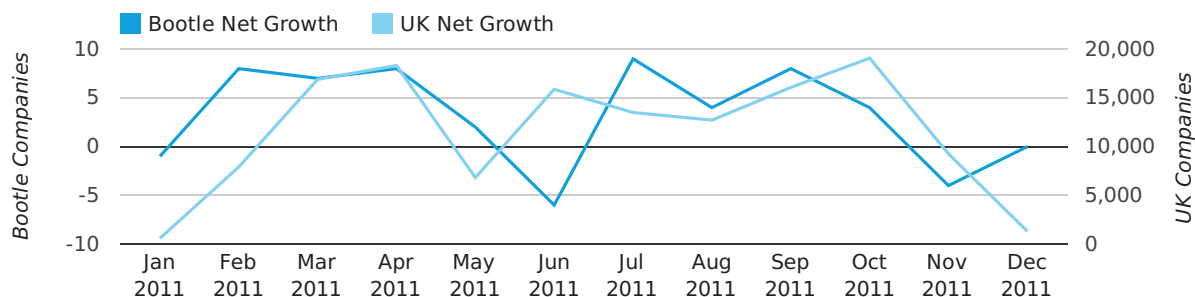

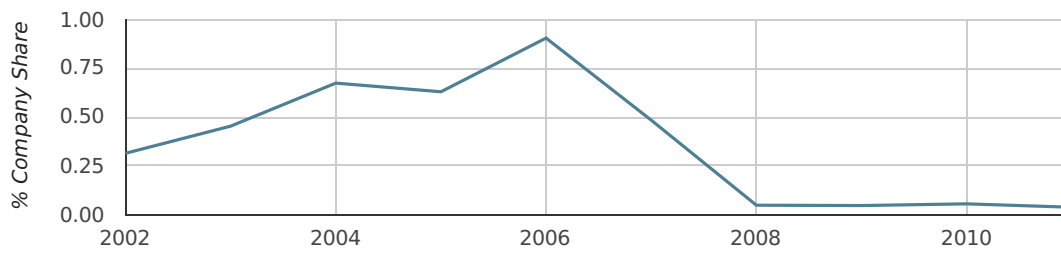

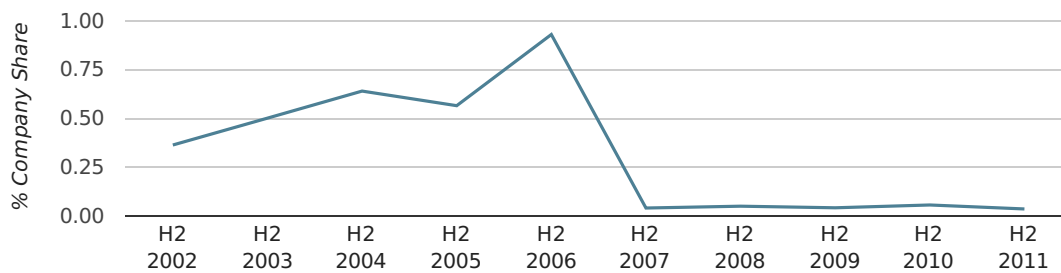

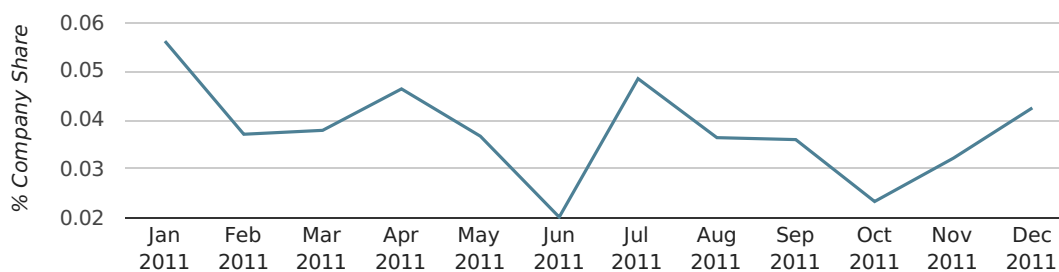

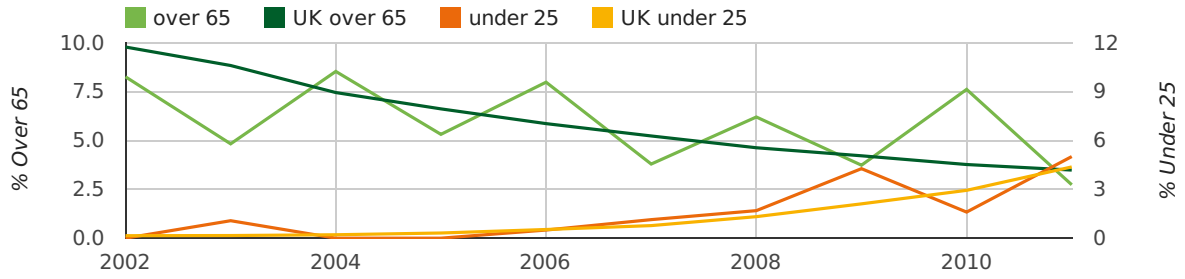

director age by year



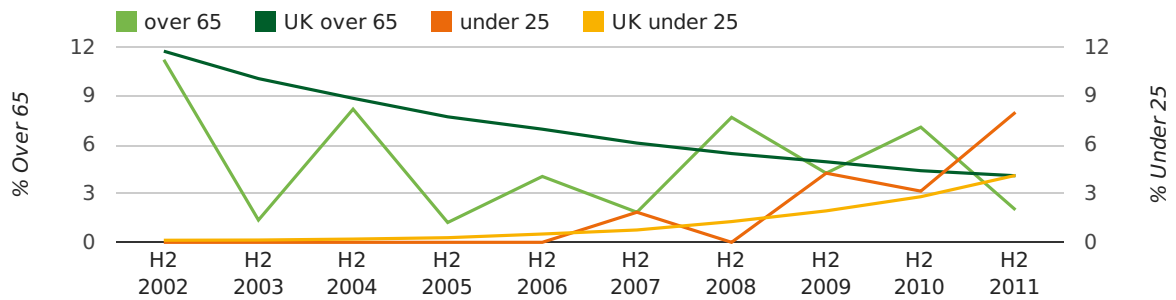

director age by half year



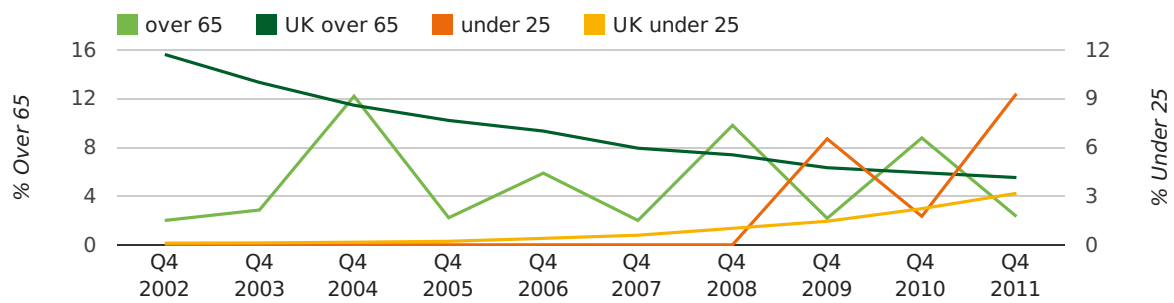

director age by quarter

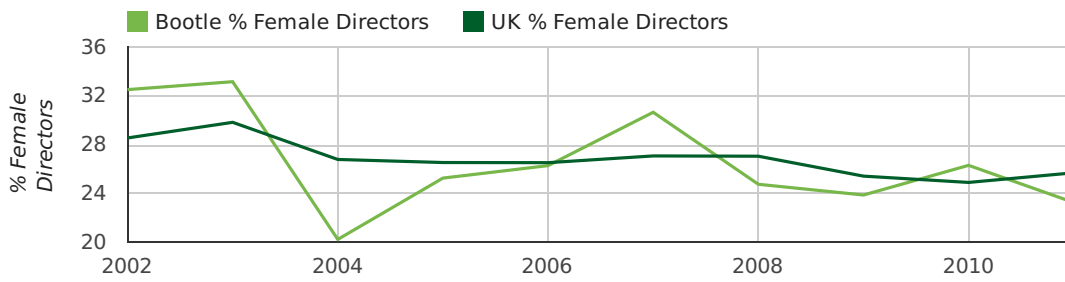


Annual Data (2011)

director gender by year

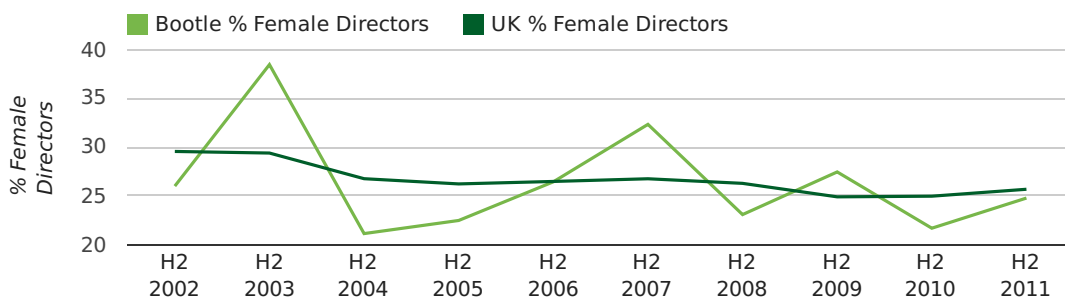


Half Year Data (Jul-Dec 2011)

director gender by half year

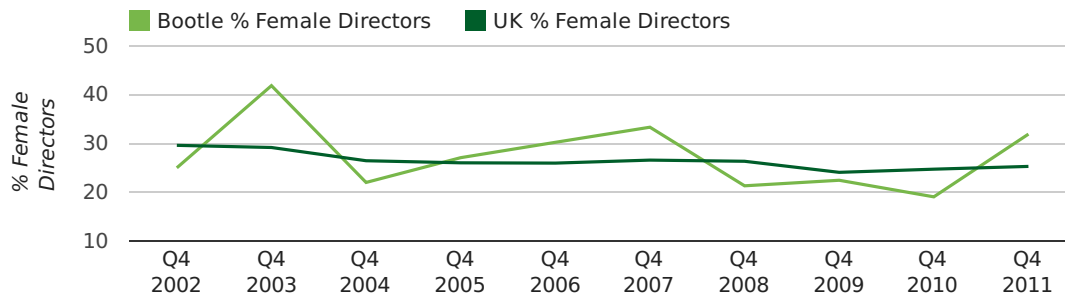


Quarterly Data (Q4 Oct-Dec 2011)
