


The first half of 2011 saw a new record in company registrations in Boston when compared to any previous first half year.

In the first half of 2011 a total of 129 companies were formed in Boston. This figure is 8.4% higher than last year, which compares badly to the UK wide figure of 12.3%.

The highest total for a first half year in Boston occurred in 2011 when a total of 129 were formed.


Q2 2011 saw a new record in company registrations in Boston when compared to any previous Q2.

A total of 66 companies were registered in Boston during the second quarter of 2011 (Apr 2011 - Jun 2011).





dissolved companies by half year





A total of 38 companies were dissolved in Boston during the second quarter of 2011 (Apr 2011 - Jun 2011).





net growth by half year













director age by half year






director age by quarter
