




## Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 111 companies were formed in Boston. This figure is 2.8% higher than last year, which compares badly to the UK wide figure of 14.0%.

The highest total for a second half year in Boston occurred in 2003 when a total of 136 were formed.


#### new companies by half year

A total of 46 companies were registered in Boston during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





dissolved companies by year




## Half Year Data (Jul-Dec 2011)

## dissolved companies by half year




A total of 35 companies were dissolved in Boston during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


A total of 89 companies were added to the company register for Boston in 2011. This number represents growth of 39.2% which compares favourably to the UK figure of 34.6%.




#### Half Year Data (Jul-Dec 2011)




Net company growth for Boston during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 11 companies.

#### net growth by quarter






company share by year







#### director age by year




## Half Year Data (Jul-Dec 2011)

The percentage of directors over the age of 65 was 9.8% compared to the UK figure of 4.1%.




The average age of a director in the fourth quarter of 2011 was 44.8.

#### director age by quarter





#### director gender by year




## Half Year Data (Jul-Dec 2011)
