


The second half of 2011 saw a new record in company registrations in Bourne when compared to any previous second half year.

new companies by half year




A total of 22 companies were registered in Bourne during the fourth quarter of 2011 (Oct 2011 - Dec 2011).






Half Year Data (Jul-Dec 2011)




A total of 11 companies were dissolved in Bourne during the fourth quarter of 2011 (Oct 2011 - Dec 2011).

2011 was a record year for net growth in Bourne when compared to any year in history.


A total of 55 companies were added to the company register for Bourne in 2011. This number represents growth of 71.4% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Bourne during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 11 companies.






company share by year




company share by half year



director age by year





director age by quarter




