


The second half of 2011 saw a new record in company registrations in Bournemouth when compared to any previous second half year.

new companies by half year




A total of 324 companies were registered in Bournemouth during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


new companies by quarter



dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 199 companies were dissolved in Bournemouth during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 540 companies were added to the company register for Bournemouth in 2011. This number represents growth of 48.4% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Bournemouth during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 125 companies.





company share by year




company share by half year





director age by year





director age by half year




director age by quarter

director gender by year




Half Year Data (Jul-Dec 2011)

director gender by half year






The record fourth quarter for female directors in Bournemouth was in 1977 when 31.1% of all directors were female.
