


The second half of 2011 saw a new record in company registrations in Bracknell when compared to any previous second half year.

new companies by half year




Q4 2011 saw a new record in company registrations in Bracknell when compared to any previous Q4.



dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




Q4 2011 saw a new record in company closures in Bracknell when compared to any previous Q4.




A total of 144 companies were added to the company register for Bracknell in 2011. This number represents growth of 33.3% which compares unfavourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Bracknell during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 14 companies.








company share by half year





director age by year





director age by half year



director gender by year


