The first half of 2011 saw a new record in company registrations in Bradford when compared to any previous first half year.


The first half of 2011 was a record first half year for company registrations in Bradford when compared to any half year in history.

In the first half of 2011 a total of 948 companies were formed in Bradford. This figure is 21.2% higher than last year, which compares well to the UK wide figure of 12.3%.

The highest total for a first half year in Bradford occurred in 2011 when a total of 948 were formed.


Q2 2011 saw a new record in company registrations in Bradford when compared to any previous Q2.

new companies by quarter





dissolved companies by half year




Quarterly Data (Q2 Apr-Jun 2011)





net growth by half year






net growth by quarter

net growth by month



company share by half year







director age by half year




