

A total of 1,877 companies were formed in Bradford in 2011. This total is 14.7% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.


The second half of 2011 saw a new record in company registrations in Bradford when compared to any previous second half year.

#### new companies by half year




Q4 2011 saw a new record in company registrations in Bradford when compared to any previous Q4.



dissolved companies by year




## Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 608 companies were dissolved in Bradford. This figure is 1.1% lower than last year, which compares badly to the UK wide change of -7.5%.

The highest total for a second half year in Bradford occurred in 2009 when a total of 701 were closed.

#### dissolved companies by half year




Q4 2011 saw a new record in company closures in Bradford when compared to any previous Q4.

A total of 344 companies were dissolved in Bradford during the fourth quarter of 2011 (Oct 2011 - Dec 2011).

This figure is an increase of 13.2% versus the same period last year (Q4 2010). This figure compares poorly to the UK as a whole, which saw an increase of 4.0% against the same period last year.


## dissolved companies by quarter


A total of 666 companies were added to the company register for Bradford in 2011. This number represents growth of 40.7% which compares favourably to the UK figure of 34.6%.

#### net growth by year




### Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Bradford during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 97 companies.

This represents an increase of 22.8% on the same period last year.




company share by year




company share by half year





#### director age by year



The percentage of directors over the age of 65 was 2.4% compared to the UK figure of 4.1%.




The average age of a director in the fourth quarter of 2011 was 40.2.

#### director gender by year




## Half Year Data (Jul-Dec 2011)

19.6% of all director appointments in Bradford in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


#### director gender by half year
