
The first half of 2012 saw a new record in company registrations in Braintree when compared to any previous first half year.

In the first half of 2012 a total of 247 companies were formed in Braintree. This figure is 36.5% higher than last year, which compares well to the UK wide figure of 10.7%.

Q2 2012 saw a new record in company registrations in Braintree when compared to any previous Q2.


Q2 2012 was a record quarter for company registrations in Braintree when compared to any quarter in history.

#### new companies by month



#### dissolved companies by half year




# Quarterly Data (Q2 Apr-Jun 2012)








company share by half year





#### director age by half year




## Quarterly Data (Q2 Apr-Jun 2012)

#### director gender by half year




# Quarterly Data (Q2 Apr-Jun 2012)
