


The second half of 2011 saw a new record in company registrations in Brentford when compared to any previous second half year.

new companies by half year




Q4 2011 saw a new record in company registrations in Brentford when compared to any previous Q4.


new companies by quarter




The second half of 2011 saw a new record in company closures in Brentford when compared to any previous second half year.

dissolved companies by half year




Q4 2011 saw a new record in company closures in Brentford when compared to any previous Q4.




A total of 76 companies were added to the company register for Brentford in 2011. This number represents growth of 36.9% which compares favourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Brentford during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 8 companies.








company share by half year





director age by year





director age by half year



director gender by year




Half Year Data (Jul-Dec 2011)
