

2011 was a record year for company registrations in Bridgnorth when compared to any year in history.

A total of 157 companies were formed in Bridgnorth in 2011. This total is 9.0% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.

Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 64 companies were formed in Bridgnorth. This figure is 8.6% lower than last year, which compares badly to the UK wide figure of 14.0%.



A total of 23 companies were registered in Bridgnorth during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





dissolved companies by year




Half Year Data (Jul-Dec 2011)




Q4 2011 saw a new record in company closures in Bridgnorth when compared to any previous Q4.


A total of 65 companies were added to the company register for Bridgnorth in 2011. This number represents growth of 45.1% which compares favourably to the UK figure of 34.6%.




Half Year Data (Jul-Dec 2011)

net growth by half year





net growth by quarter






company share by year





director gender by year




Half Year Data (Jul-Dec 2011)

29.4% of all director appointments in Bridgnorth in the second half of 2011 were female. This compares to a UK average of 25.7% for the same period.


director gender by half year
