• December 2011 saw a new record in company closures in Bridlington when compared to any previous December.



new companies by year




Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 85 companies were formed in Bridlington. This figure is 54.5% higher than last year, which compares well to the UK wide figure of 14.0%.

The highest total for a second half year in Bridlington occurred in 2003 when a total of 162 were formed.

new companies by half year




A total of 45 companies were registered in Bridlington during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





dissolved companies by year




Half Year Data (Jul-Dec 2011)

dissolved companies by half year




A total of 36 companies were dissolved in Bridlington during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


dissolved companies by quarter


A total of -13 companies were removed to the company register for Bridlington in 2011. This number represents decline of 11.3% which compares unfavourably to the UK figure of 34.6%.

net growth by year




Half Year Data (Jul-Dec 2011)

net growth by half year




Net company growth for Bridlington during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 9 companies.








company share by half year





director age by year





director age by half year



director gender by year




Half Year Data (Jul-Dec 2011)
