

2011 was a record year for company registrations in Brighton when compared to any year in history.

A total of 1,736 companies were formed in Brighton in 2011. This total is 12.7% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.

## Half Year Data (Jul-Dec 2011)


The second half of 2011 saw a new record in company registrations in Brighton when compared to any previous second half year.

In the second half of 2011 a total of 859 companies were formed in Brighton. This figure is 10.0% higher than last year, which compares badly to the UK wide figure of 14.0%.

#### new companies by half year




A total of 396 companies were registered in Brighton during the fourth quarter of 2011 (Oct 2011 - Dec 2011).


#### new companies by quarter



#### dissolved companies by year




## Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 620 companies were dissolved in Brighton. This figure is 1.3% lower than last year, which compares badly to the UK wide change of -7.5%.

The highest total for a second half year in Brighton occurred in 2009 when a total of 662 were closed.

#### dissolved companies by half year




Q4 2011 saw a new record in company closures in Brighton when compared to any previous Q4.

A total of 318 companies were dissolved in Brighton during the fourth quarter of 2011 (Oct 2011 - Dec 2011).

This figure is an increase of 2.3% versus the same period last year (Q4 2010). This figure compares well to the UK as a whole, which saw an increase of 4.0% against the same period last year.


#### dissolved companies by quarter


A total of 471 companies were added to the company register for Brighton in 2011. This number represents growth of 30.6% which compares unfavourably to the UK figure of 34.6%.

This number is 182 companies higher than the previous year.

The highest net company growth figure ever seen in one year came in 2003 when the Brighton company register grew by 1,042 companies.




#### Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Brighton during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 78 companies.



#### company share by year




#### company share by half year





#### director age by year





#### director age by half year




The average age of a director in the fourth quarter of 2011 was 42.4.

The percentage of directors over the age of 65 was 2.2% compared to the UK figure of 4.1%.


## director age by quarter

#### director gender by year




# Half Year Data (Jul-Dec 2011)
