Q1 2012 saw a new record in company registrations in Brighton when compared to any previous Q1.


Q1 2012 was a record quarter for company registrations in Brighton when compared to any quarter in history.

A total of 491 companies were registered in Brighton during the first quarter of 2012 (Jan 2012 - Mar 2012).

This figure is an increase of 7.4% versus the same period last year (Q1 2011). This figure compares equally to the UK as a whole, which saw an increase of 13.0% against the same period last year.

new companies by quarter










net growth by quarter






