

A total of 6,160 companies were formed in Bristol in 2011. This total is 13.8% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.

## Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 3,052 companies were formed in Bristol. This figure is 12.8% higher than last year, which compares badly to the UK wide figure of 14.0%.

The highest total for a second half year in Bristol occurred in 2006 when a total of 3,243 were formed.

#### new companies by half year




A total of 1,450 companies were registered in Bristol during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





## dissolved companies by year




## Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 2,046 companies were dissolved in Bristol. This figure is 17.1% lower than last year, which compares well to the UK wide change of -7.5%.

The highest total for a second half year in Bristol occurred in 2009 when a total of 4,379 were closed.

## dissolved companies by half year




A total of 1,076 companies were dissolved in Bristol during the fourth quarter of 2011 (Oct 2011 - Dec 2011).




A total of 1,837 companies were added to the company register for Bristol in 2011. This number represents growth of 33.9% which compares unfavourably to the UK figure of 34.6%.

This number is 1,492 companies higher than the previous year.

The highest net company growth figure ever seen in one year came in 2007 when the Bristol company register grew by 4,563 companies.




## Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Bristol during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 374 companies.

This represents an increase of 117.4% on the same period last year.













#### director age by year




## Half Year Data (Jul-Dec 2011)

#### director age by half year




The average age of a director in the fourth quarter of 2011 was 44.4.

#### director gender by year




## Half Year Data (Jul-Dec 2011)

## director gender by half year


