

A total of 106 companies were formed in Broadstairs in 2011. This total is 5.4% lower than in 2010 and compares favourably to the UK figure of a 13.1% growth compared to 400,358 the previous year.

#### new companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 63 companies were formed in Broadstairs. This figure is 46.5% higher than last year, which compares well to the UK wide figure of 14.0%.

The highest total for a second half year in Broadstairs occurred in 2002 when a total of 71 were formed.

#### new companies by half year




A total of 30 companies were registered in Broadstairs during the fourth quarter of 2011 (Oct 2011 - Dec 2011).





#### dissolved companies by year




#### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 39 companies were dissolved in Broadstairs. This figure is 21.9% higher than last year, which compares badly to the UK wide change of -7.5%.

#### dissolved companies by half year




Q4 2011 saw a new record in company closures in Broadstairs when compared to any previous Q4.

This figure is an increase of 40.0% versus the same period last year (Q4 2010). This figure compares poorly to the UK as a whole, which saw an increase of 4.0% against the same period last year.

#### dissolved companies by quarter




A total of 40 companies were added to the company register for Broadstairs in 2011. This number represents growth of 35.7% which compares favourably to the UK figure of 34.6%.

#### net growth by year




#### Half Year Data (Jul-Dec 2011)

#### net growth by half year




Net company growth for Broadstairs during the fourth quarter of 2011 (Oct 2011 - Dec 2011) was 9 companies.


#### net growth by quarter






#### company share by half year





#### director age by year





#### director age by half year




The average age of a director in the fourth quarter of 2011 was 43.7.

#### director gender by year




## Half Year Data (Jul-Dec 2011)
