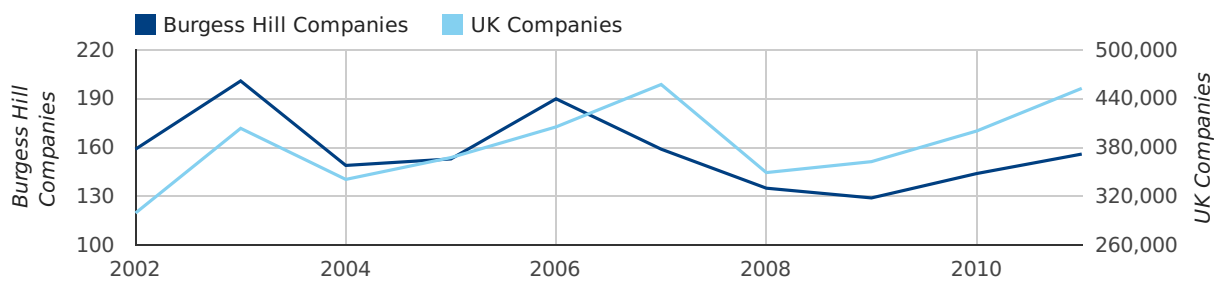

### Annual Data (2011)

A total of 156 companies were formed in Burgess Hill in 2011. This total is 8.3% higher than in 2010 and compares equally to the UK figure of a 13.1% growth compared to 400,358 the previous year.

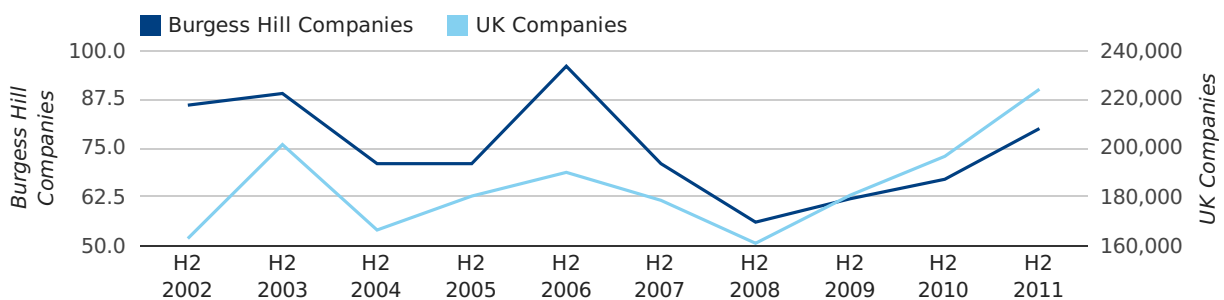
### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 80 companies were formed in Burgess Hill. This figure is 19.4% higher than last year, which compares well to the UK wide figure of 14.0%.

The highest total for a second half year in Burgess Hill occurred in 2006 when a total of 96 were formed.

### new companies by half year



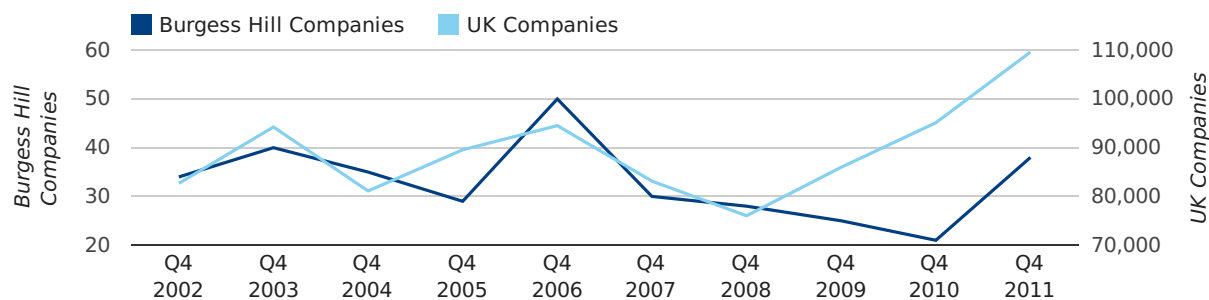
## Quarterly Data (Q4 Oct-Dec 2011)

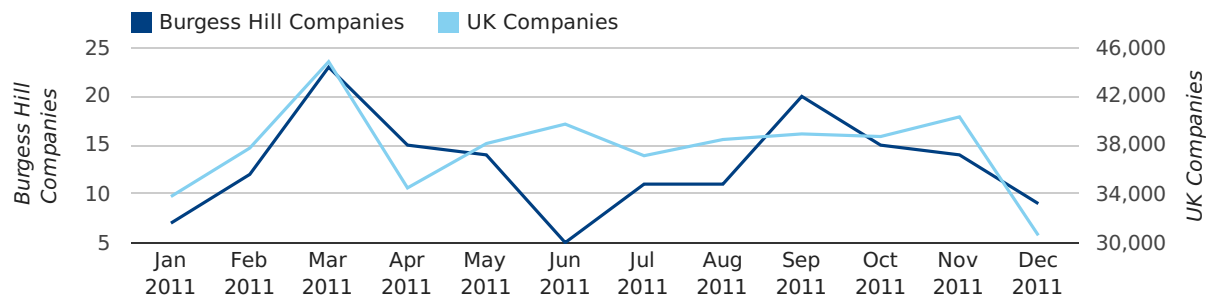

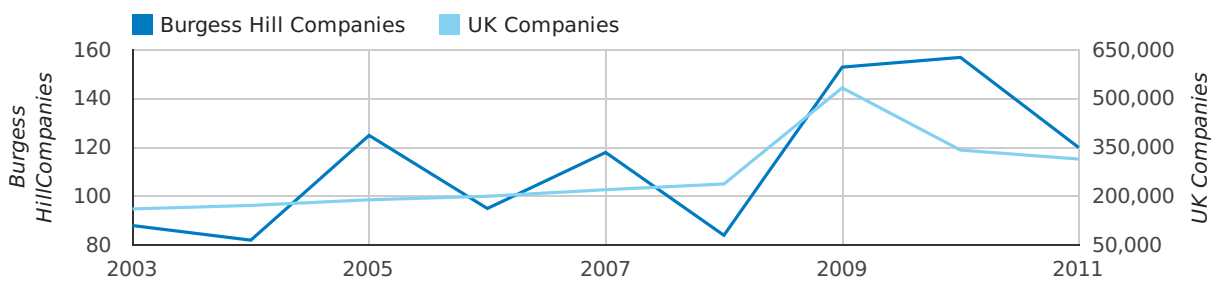

A total of 120 companies were dissolved in Burgess Hill in 2011. This total is 23.6% lower than in 2010 and compares unfavourably to the UK figure of 8.1% decrease compared to the previous year.

### dissolved companies by year



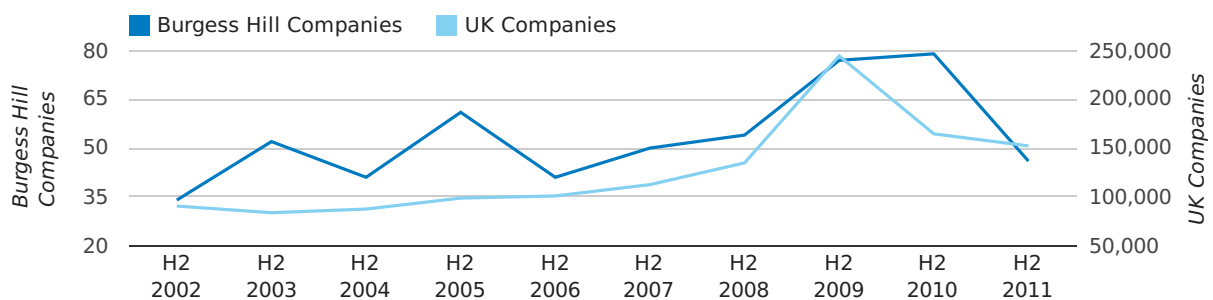
### Half Year Data (Jul-Dec 2011)

In the second half of 2011 a total of 46 companies were dissolved in Burgess Hill. This figure is 41.8% lower than last year, which compares well to the UK wide change of -7.5%.

The highest total for a second half year in Burgess Hill occurred in 2010 when a total of 79 were closed.

### dissolved companies by half year



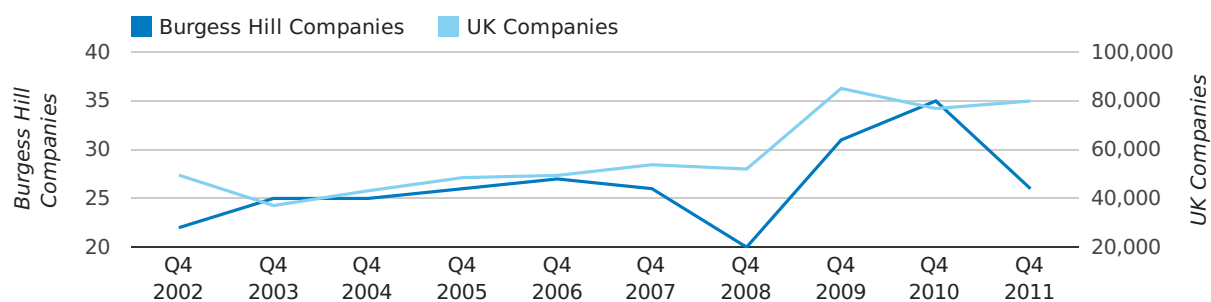
## Quarterly Data (Q4 Oct-Dec 2011)

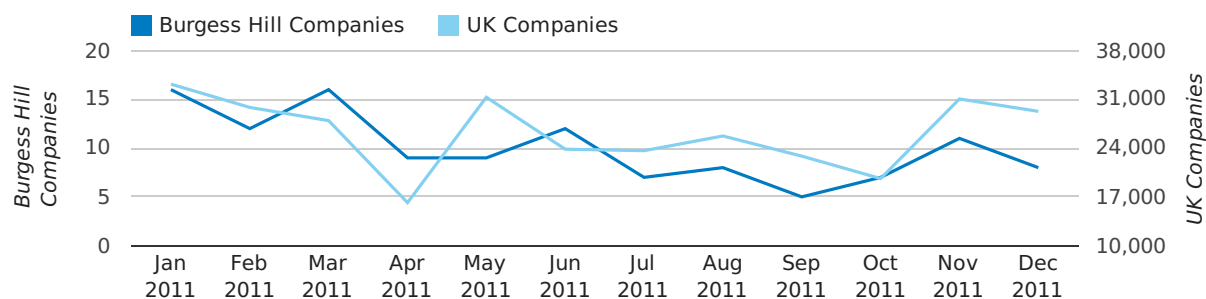

### Annual Data (2011)

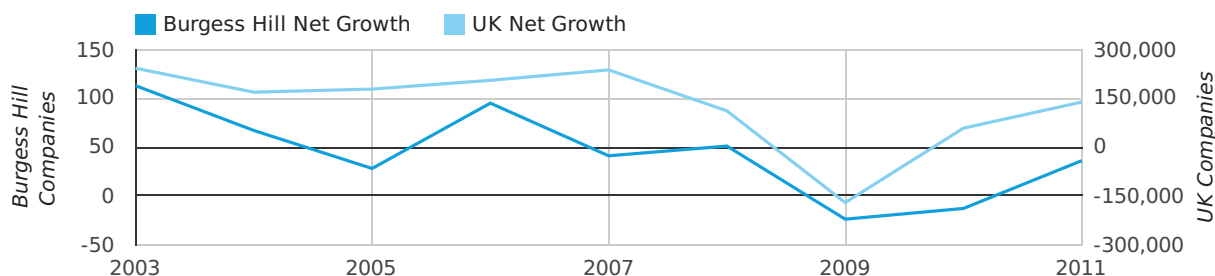

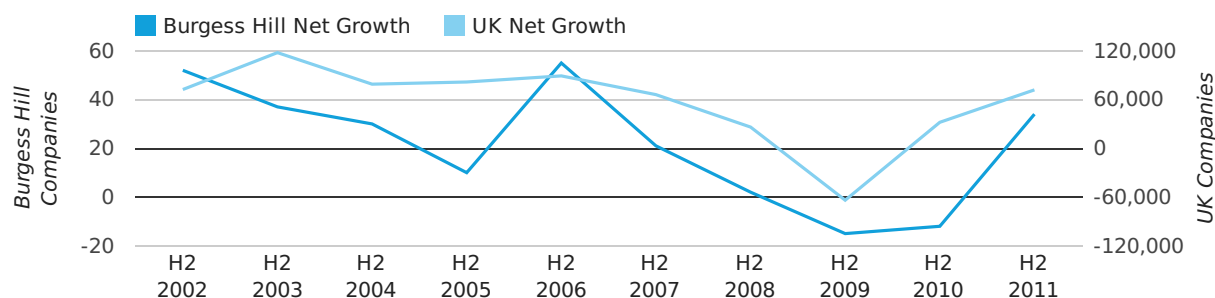


### Half Year Data (Jul-Dec 2011)

### net growth by half year



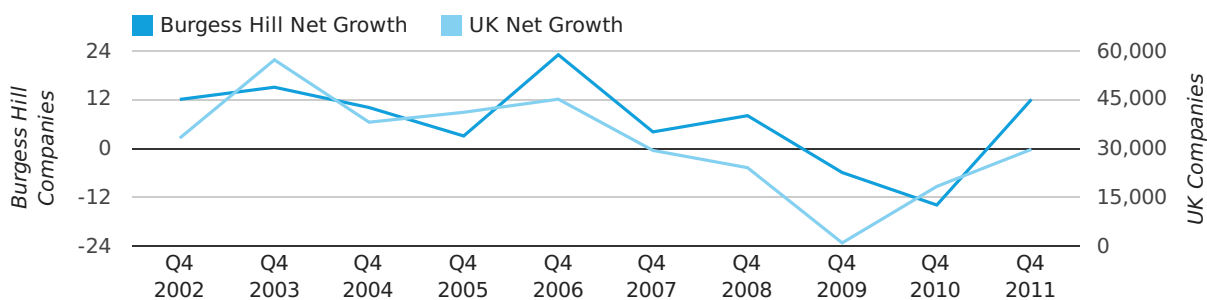
## Quarterly Data (Q4 Oct-Dec 2011)

This represents an increase of 185.7% on the same period last year.

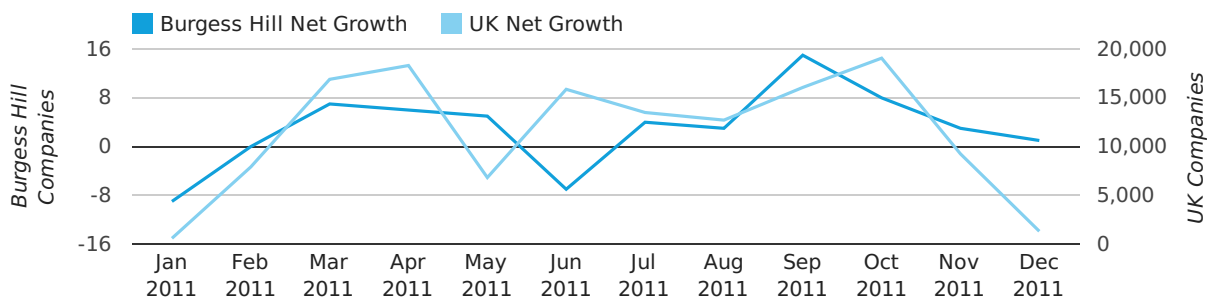

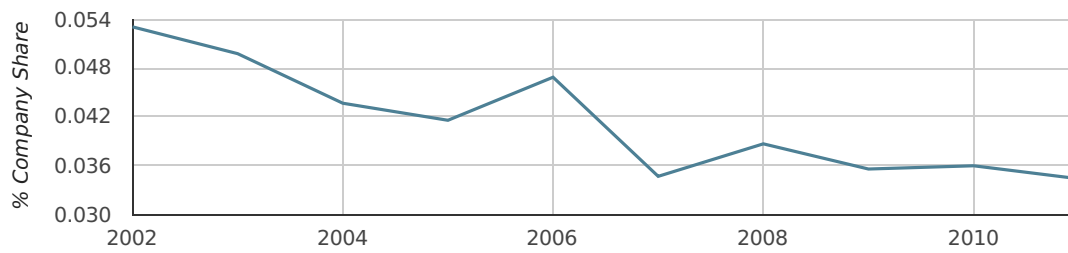

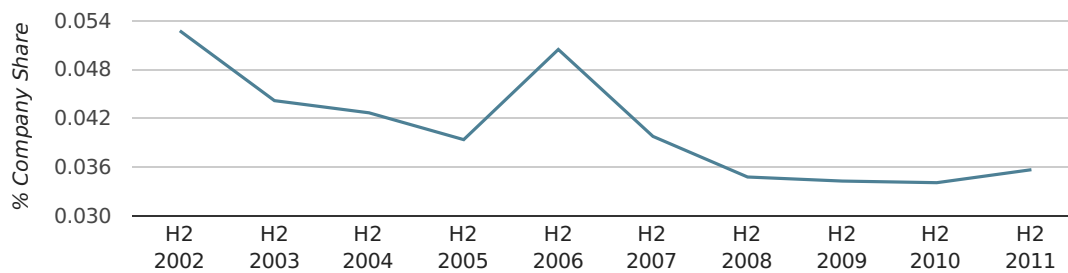

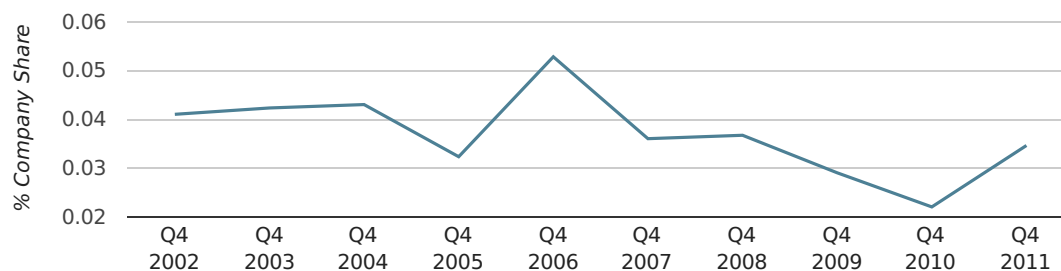

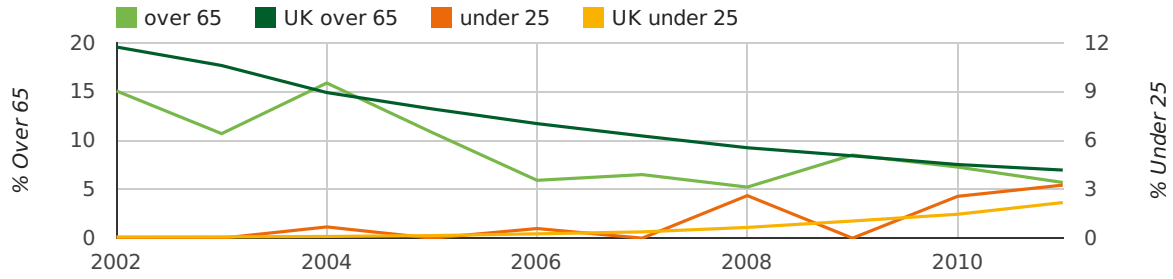
### Annual Data (2011)

#### director age by year



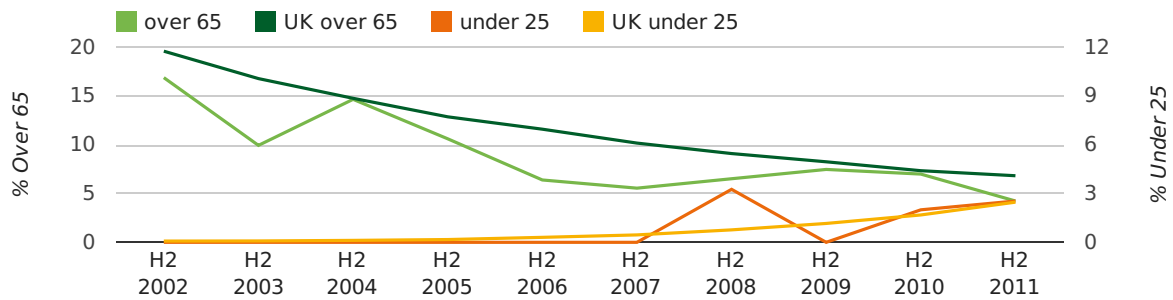
### Half Year Data (Jul-Dec 2011)

#### director age by half year



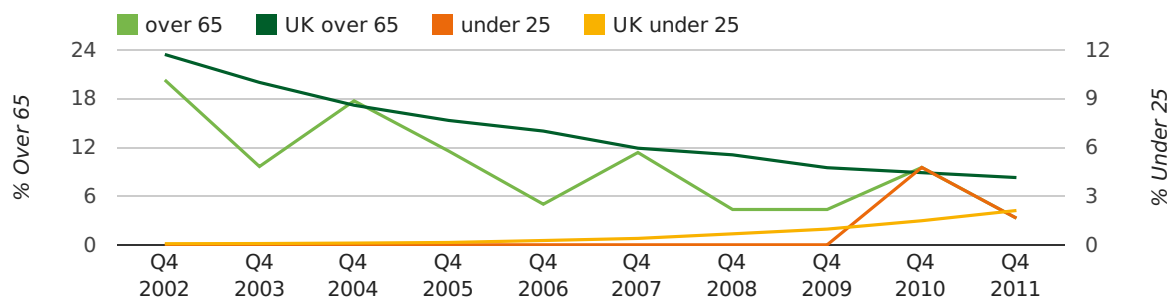

### director age by quarter

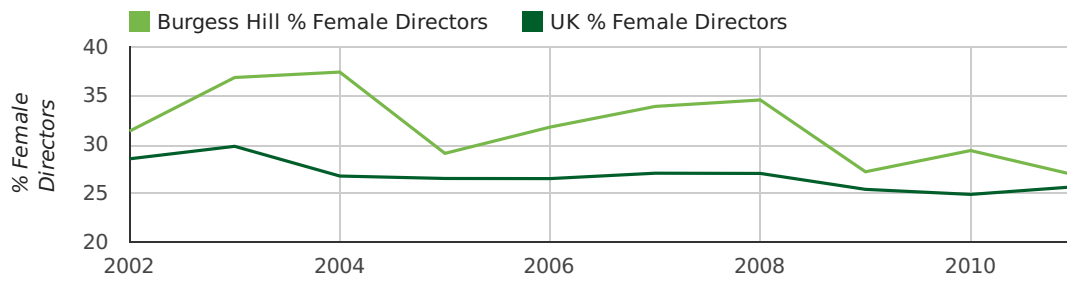


### Annual Data (2011)

#### director gender by year

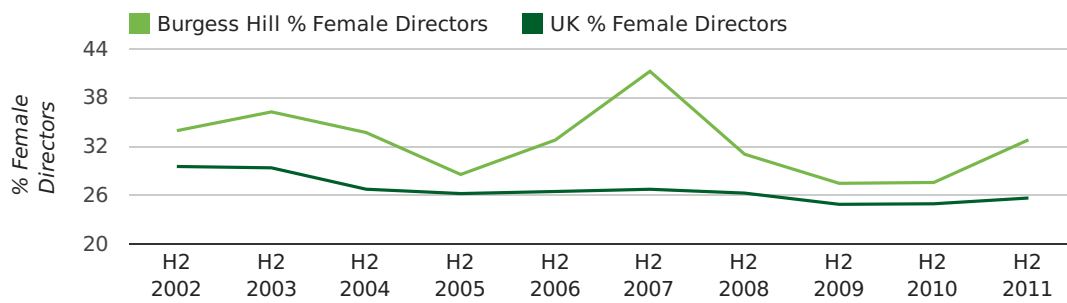


### Half Year Data (Jul-Dec 2011)

#### director gender by half year

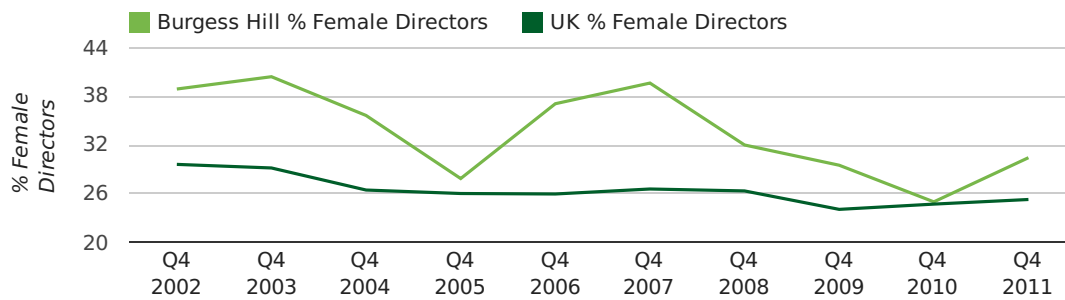


## Quarterly Data (Q4 Oct-Dec 2011)

The record fourth quarter for female directors in Burgess Hill was in 1977 when 31.1% of all directors were female.
